# Clarification & Extension for bid submission

With reference to Request for Proposal (RFP) for Tariff Discovery and Selection of Solar Power Developers for Implementation of an Aggregate Capacity of 500 MW, with a 50% 'GREENSHOE' Option, for Grid-Connected Rooftop Solar PV Projects under the RESCO Model, for Sale of Solar Power at Various MSME Units in the States of Maharashtra, Goa, Gujarat, Uttar Pradesh, and Andhra Pradesh, it is hereby conveyed that:

- 1) The last date for bid submission is 3:00 PM on 13/08/2025.
- 2) The technical bid opening is 03.00 PM on 14/08/2025.

## The following is a clarification for Section 2 - Bid Details, Clause number 2.8: -

The bidder shall be required to submit a bid for a minimum capacity of 25 MW in overall categories, and the bidder can submit a bid for a maximum 200 MW including all categories. Bidder are mandatory required to submit the bid of minimum 10% of bided Quantity in A1 category (20kW – 100 kW). Bids quoting less than 25 MW in overall categories and bids quoting less than 10% of the total bided quantity in A1 category shall be deemed non-responsive and shall not be considered for evaluation. MAHAPREIT reserves the right to determine and allocate the project capacity across the states and categories as deemed appropriate.

#### Illustration: -

If bidders are submitting a bid for 25 MW, then bidders are required to bid a minimum of 10 % of 25 MW, i.e. 2.5 MW in the A1 category, and bidders may bid the balance bid capacities into the remaining categories A2, A3, and A4.

Bid capacity/Quantity	Category A1 (minimum 10% or more)	Category A2, A3, and A4
25 MW	Minimum 2.5 MW or more	Balance capacity/Quantity
50 MW	5.0 MW or more	Balance capacity/Quantity
75 MW	7.5 MW or more	Balance capacity/Quantity
100 MW	10.0 MW or more	Balance capacity/Quantity
And so on

- 2) Other terms and conditions in the tender document shall remain unchanged.
