Mahatma Phule Renewable Energy and Infrastructure Technology Ltd (MAHAPREIT) a Subsidiary of Mahatma Phule Backward Class Development Corporation Limited (MPBCDC) is a premier Public Sector Undertaking of the Government of Maharashtra it was set up in April 2021 to venture into RE and Green technology areas and infrastructure projects and was allowed to take up RE and Green energy, Infrastructure projects on Govt-to-Govt basis (G2G basis) vide GR dated 10th July 2023. MAHAPREIT's strategic business verticals are the pillars through which it executes its dual mission: driving sustainable development across Maharashtra and ensuring inclusive economic growth for marginalized communities. Each vertical is designed to create self-sustaining business models that not only generate revenue for social upliftment but also position the state as a leader in green technology, digital infrastructure, and social empowerment MAHAPREIT implements "NAVYUG SCHEME" to get the integrated, inclusive and comprehensive effects of all the input supports of MAHAPREIT company to the target beneficiaries of MPBCDC Limited as defined from time to time by Govt of Maharashtra.

➤ **Factory Visit:**

1. Authorized representative(s) of MAHAPREIT will conduct a factory visit of the manufacturer before registration.
2. All expenses related to the visit shall be borne by the Vendor/Applicant.
3. Based on the observations of the factory visit conducted after document verification and satisfying eligibility criteria, the decision for the product approval and registration will be taken with approval from the competent authority of MAHAPREIT.

➤ **Registration charges:**

1. Document fees (Non-Refundable) of **Rs. 11,800/-** (Rupees Eleven Thousand Eight Hundred Only) (Including GST) through online payment to the MAHAPREIT Bank account, along with the Application for the Vendor Registration.

i. Timely Supply Capability

The applicant shall possess adequate technical, financial, and logistical capacity to supply and deliver the required materials within stipulated timelines, including supply at short notice, as per the exigencies of the project.

ii. Coordination with Development Agencies

The empanelled / registered vendors may be required to coordinate with MAHAPREIT and its appointed Development Agencies, Project Implementation Agencies, Project Management Consultants (PMCs), or any other agencies engaged by MAHAPREIT, as and when required for project-related supplies.

iii. Invitation of Quotations

For procurement of materials for various projects undertaken by MAHAPREIT, quotations may be invited from the registered vendors in the first instance. However, MAHAPREIT reserves the right to invite quotations from any other source as deemed necessary.

iv. Circulation of Vendor List

The list of vendors registered with MAHAPREIT may be recommended to the Development Agencies / Consultants / PMCs engaged for MAHAPREIT projects for their reference and use, as per project requirements.

v. Non-binding Nature of Registration

Registration/empanelment with MAHAPREIT shall not confer any right for award of work or guarantee of minimum business. MAHAPREIT reserves the right to accept or reject any application, cancel the registration, or modify the terms and conditions without assigning any reason.

vi. Discretion of MAHAPREIT

MAHAPREIT's decision in respect of registration, continuation, suspension, or cancellation of vendor registration shall be final and binding on the applicant.

vii. Incomplete applications or those submitted after the due date and time will not be considered.

- viii. MAHAPREIT may call for registration of additional materials, as required, from time to time.

➤ **Post-Registration Procedure**

1. All applications received for vendor registration shall be scrutinized by MAHAPREIT with respect to eligibility, technical capability, experience, and documents submitted.
2. Applicants found eligible and suitable shall be approved for registration, and intimation of registration shall be issued through official communication. Such vendors shall be included in the approved list of registered vendors maintained by MAHAPREIT.
3. The registration shall be valid for a period as may be decided by MAHAPREIT, unless suspended or cancelled earlier. Continuation of registration shall be subject to satisfactory performance and compliance with MAHAPREIT's terms and conditions.
4. After registration, vendors shall become eligible to participate in Limited Tenders, or other procurement processes issued by MAHAPREIT and/or its Development Agencies, as per project requirements.
5. For each procurement process, registered vendors shall submit bids/quotations strictly in accordance with the terms, specifications, and timelines stipulated in the respective tender/RFQ documents.
6. Performance of registered vendors shall be monitored during execution. In case of unsatisfactory performance, delay, non-compliance, or breach of conditions, MAHAPREIT reserves the right to suspend or cancel the registration.
7. The decision of MAHAPREIT regarding registration, continuation, suspension, or cancellation of vendor registration shall be final and binding on the applicant.

1. Cement:

A. Material Specification: Vendor shall be capable of supplying Ordinary Portland Cement (OPC) – 43 Grade / 53 Grade, Portland Pozzolana Cement (PPC) and Portland Slag Cement (PSC) and other types of cement as per project requirement and relevant IS Codes and project specification.

B. Testing & Inspection: All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All **latest** material test reports shall be submitted for vendor registration. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.

C. Experience Criteria: Minimum **7 years'** experience and supply of minimum **1,00,000 MT** cement in last **5 years**.

D. Annual Turnover: Minimum average annual turnover of **₹2,000** Crore during last 3 financial years.

E. Sustainability & Green Requirements: Preference to PPC/PSC with fly ash/GGBS, compliance with CPCB/SPCB norms.

2. Bricks / Blocks/ Light Weight Blocks using Fly Ash and Wall Panels:

A. Material Specification: Bricks / Blocks/ Light Weight Blocks using Fly Ash and Wall Panels shall conform to relevant IS Codes and project specification. Bricks shall be uniform in shape, size and colour, free from cracks and defects, with permissible water absorption and compressive strength as per IS standards.

B. Testing & Inspection: All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All **latest** material test reports shall be submitted for vendor registration. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.

- C. Experience Criteria:** Minimum **7 years'** experience in manufacturing/supply. Must have supplied minimum **200 lakh** Fly Ash Bricks and Wall Panels to housing/infrastructure projects in last **5 years**.
- D. Annual Turnover:** Minimum average annual turnover of **₹100** Crore during last 3 financial years.
- E. Sustainability & Green Requirements:** Bricks shall contain minimum 50–70% fly ash, promoting utilization of industrial waste and reducing use of natural clay. Wall Panels should have minimal volatile organic compound emissions. Manufacturing unit shall comply with SPCB/CPCB norms.

3. Reinforcement

- A. Material Specification:** TMT steel bars shall conform relevant IS Codes and project specification. Steel shall be ISI marked and supplied with manufacturer's test certificate.
- B. Testing & Inspection:** All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All **latest** material test reports shall be submitted for vendor registration. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.
- C. Experience Criteria:** Minimum **7 years'** experience with supply of at least **1,00,000 MT** steel in last **5 years**.
- D. Annual Turnover:** Minimum average annual turnover of **₹2,000** Crore during last 3 financial years.

4. Ready Mix Concrete (RMC)

- A. Material Specification:** RMC shall conform to relevant IS Codes and project specification. Concrete shall be produced from automated batching plants.
- B. Testing & Inspection:** All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All **latest** material test reports shall be submitted for vendor registration. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.
- C. Experience Criteria:** Minimum **7 years'** experience with supply of at least **1,50,000 Cum** RMC in last **5 years**.
- D. Annual Turnover:** Minimum average annual turnover of **₹200** Crore during last 3 financial years.
- E. Sustainability & Green Requirements:** RMC shall incorporate fly ash/GGBS to reduce cement content. RMC plants shall recycle wash water and minimize waste.

5. Plumbing & Sanitary Materials.

- A. Material Specification:** CPVC/UPVC/HDPE/GI pipes and fittings shall conform to relevant IS Codes and project specification.
- B. Testing & Inspection:** All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All **latest** material test reports shall be submitted for vendor registration. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.
- C. Experience Criteria:** Minimum **7 years'** experience with supply for at least **20,000** dwelling units.
- D. Annual Turnover:** Minimum average annual turnover of **₹150** Crore during last 3 financial years.
- E. Sustainability & Green Requirements:** Materials shall be corrosion-resistant, durable, recyclable and minimize water leakage and losses.

6. Elevators / Lifts

- A. Material Specification:** Elevators shall conform to relevant IS Codes and project specification. Supply shall include installation, testing and commissioning.
- B. Testing & Inspection:** All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All **latest** material test reports shall be submitted for vendor registration. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.
- C. Experience Criteria:** Minimum **7 years'** experience and installation of at least **1,000** elevators in last **5 years**.
- D. Annual Turnover:** Minimum average annual turnover of **₹500** Crore during last 3 financial years.
- E. Sustainability & Green Requirements:** Elevators shall be energy-efficient with VVVF drives, LED lighting and power-saving standby modes.

7. Electrical Fittings & Generators

- A. Material Specification:** Electrical fittings shall conform to relevant IS standards. DG Sets shall comply with CPCB emission norms.
- B. Testing & Inspection:** All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All **latest** material test reports shall be submitted for vendor registration. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.
- C. Experience Criteria:** Minimum **7 years'** experience in supply and installation.
- D. Annual Turnover:** Minimum average annual turnover of **₹200** Crore during last 3 financial years.
- E. Sustainability & Green Requirements:** Preference to energy-efficient electrical fittings, LED lighting systems and low-emission DG sets.

8. Interior / Exterior Paints

- A. Material Specification:** Interior and exterior paints including primers, putty and protective coatings shall conform to relevant IS Codes and project specification. Exterior paints shall be weather-resistant, UV-resistant and suitable for Indian climatic conditions.
- B. Testing & Inspection:** All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All **latest** material test reports shall be submitted for vendor registration. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.
- C. Experience Criteria:** Minimum **7 years'** experience and execution of painting work for minimum **1 lakh sq.m** built-up area.
- D. Annual Turnover:** Minimum average annual turnover of **₹500** Crore during last 3 financial years.
- E. Sustainability & Green Requirements:** Paints shall be low VOC/zero VOC, lead-free and free from harmful heavy metals to enhance indoor air quality.

9. Doors / Windows – Shutters & Frames

- A. Material Specification:** Door and window shutters and frames made of wood, aluminium, UPVC or steel shall conform to relevant IS Codes and project specification.
- B. Testing & Inspection:** All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All material test reports submitted for vendor registration must be current and shall **not be older than two months** from the date of submission. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.

- C. Experience Criteria:** Minimum **7 years'** experience with supply and installation for at least **5,000** dwelling units.
- D. Annual Turnover:** Minimum average annual turnover of **₹150** Crore during last 3 financial years.
- E. Sustainability & Green Requirements:** Preference to energy-efficient systems, recyclable materials and certified sustainable timber where applicable.

10. Fire Fighting System

- A. Material Specification:** Firefighting systems including fire hydrants, sprinklers, pumps, pipelines, valves, detectors and accessories shall conform to relevant IS Codes and project specification.
- B. Testing & Inspection:** All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All **latest** material test reports shall be submitted for vendor registration. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost. Certification from local Fire Authority shall be mandatory.
- C. Experience Criteria:** Minimum **7 years'** experience in design, supply, installation and commissioning of fire fighting systems for residential/high-rise buildings.
- D. Annual Turnover:** Minimum average annual turnover of **₹100** Crore during last 3 financial years.
- E. Sustainability & Green Requirements:** Systems shall be energy-efficient, reliable and designed to minimize water and power consumption.

11. Tiles for Flooring and Wall Cladding:

- A. Material Specification:** Flooring materials such as vitrified tiles, ceramic tiles, stone flooring, terrazzo or eco-friendly flooring systems shall conform to relevant IS codes and project specifications.
- B. Testing & Inspection:** All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All material test reports submitted for vendor registration must be current and shall **not be older than two months** from the date of submission. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.
- C. Experience Criteria:** Minimum **7 years'** experience with supply and installation of flooring works for at least **1 lakh** Sq.m area.
- D. Annual Turnover:** Minimum average annual turnover of **₹200** Crore during last 3 financial years.
- E. Sustainability & Green Requirements:** Preference to low-maintenance, durable, recyclable and eco-friendly flooring materials.

12. Waterproofing & Protective Materials

- A. Material Specification:** Waterproofing & Protective Materials like liquid-applied membranes, cementitious coatings, sheet membranes, crystalline waterproofing compounds, protective coatings for concrete and steel shall conform to relevant IS Codes and project specification.
- B. Testing & Inspection:** All tests shall conform to relevant IS codes and be certified by CBRI or a NABL-accredited laboratory. Random sampling and testing at manufacturer's plant, site laboratory or NABL-accredited laboratory. All **latest** material test reports shall be submitted for vendor registration. Cost of testing shall be borne by vendor. Rejected material shall be replaced at vendor's cost.
- C. Experience Criteria:** Minimum **7 years'** experience in applying waterproofing and protective coatings in high-rise buildings.

- D. Annual Turnover:** Minimum average annual turnover of ₹100 Crore during last 3 financial years.
- E. Sustainability & Green Requirements:** Systems shall be energy-efficient, reliable and designed to minimize water and power consumption.
